I'm attaching comments that I sent to Imants on the first draft of the ToR that went out in April. My comments dated April 28, 2006, still stand.

Overall, draft II is heading in the right direction. My comments, just try to tighten some things up.

I also wanted to add the following:

- Terminology – please try to use consistent terminology throughout. If an acronym has been defined then be consistent and use the acronym.
- Section 1.1 – ends with the 1994 Study. What has happened between 1994 and 2006? You should fill in the gap and explain how GO Transit has gotten to where it is today. Also highlight the fact that GO Transit has volunteered to complete an individual EA, when the project fits into GO Transits Class EA process
- GTTA – Section 2 identifies that GO Transit is officially the GTTA – how does this fit into the proposed GTTA proposed legislation?
- Section 4.2.1 – the last paragraph states “During the EA, the proponent will work closely with the affected agencies and public...” you should add Aboriginal Communities as a group you will work with.
