Further to what we talked about, it might be worthwhile to forward some specific comments to GO Transit which I am in the process of preparing for the MTO 401 Widening Project that address this Reg. 419/05 Standards issue.

This can be done through an Email that I could prepare for you and you could then send on to them.

After thinking about it further as I prepare the MTO comments, my specific concern is that I do not want GO Transit to get the impression that this is a point to be negotiated with me some time during a future meeting. If I can give clarification now as to our position on the matter, they will understand up-front that this is the approach we are going to recommend and it won't likely change regardless of what they would say in any meeting.

Essentially it is a pretty straight forward approach....you use the best available numbers for the Air Quality Impact Assessment, which are the Reg. 419/05 Schedule 3 Standards values and you use them in a non-compliance, comparative analysis manner.

Hi Ernie

To follow-up on our conversation yesterday, I wanted to let you know how things have been resolved with GO Transit for the Georgetown South Corridor Expansion and Airport Transportation Link ToR.

I explained to GO Transit that you asked for parameters in Reg 419 to be used because some parameters can only be found in that regulation. I also explained that you are not asking that the regulation be used to determine compliance but will only be used to outline parameters. GO Transit would like to discuss this further with you. As such, they have committed in its responses to contact Central Region TSS (i.e., you) before beginning the AQ assessment. This will allow MOE and GO Transit to discuss the requirements for the AQ. I believe that this commitment deals with the issues you raised.
